Section 3 New Rules Change (July 1, 2021¹):



For Community Development Agencies (Cities, Counties, others):

- This new rule applies to housing rehabilitation, housing construction, and other public construction projects assisted under HUD programs when the total amount of federal assistance to the project from such programs exceeds a threshold of \$200,000.
- Funding source includes CDBG, HOME, ESG, NSP, etc.
- All reporting under the new rules start *July 1, 2021*.
- All current Section 3 businesses and workers will need to **RE-APPLY** for certification. Certification is free. Businesses and workers seeking Section 3 status can now self-certify.
