# Immigration related developments and updates

Public Charge and Lift the Bar Act, Mid Minnesota Legal Aid (Anne Quincy, Danielle Hendrickson)

- Trump administration published public charge rule—vacated by President Biden, whose administration has returned us to public charge analysis contained in 1999 guidance.
- USCIS is publishing new notice of proposed rule-making, which for the most part follows the 1999 guidance. - In new proposed rule, public charge does not apply to anyone who uses refugee services, even if they have not been declared a refugee. Doesn't apply to Temporary Protected Status (TPS), Liberian Refugee Immigrant Fairness Act (LRIF), or recent Afghan arrivals.
- Biggest change is food assistance, emergency assistance affects public charge. No healthcare benefits except Medicaid for Nursing Home care.
- Bottom line benefits are complex, it is safe to apply. You are not a recipient if you applied and were turned down. You are not a recipient if you are applying for your children. We can safely say, there are no benefits for which you would be eligible, and would affect public charge. Please call MMLA if you have questions. You'll get to someone who speaks your language. federal register notice on public charge:
- 5 year bar legislation house sponsors, none in Senate. Proposal to reform 5-year bar issues.

- The American Families United Act, HR2920, seeks to expand waiver to cover administrative inadmissibility, not criminal issues.
- Bill is active in the House and there is an active campaign to recruit a sponsor in Senate.

- Afghan Adjustment Act—at present there is no streamlined way for Afghan evacuees to obtain permanent residence in the US. Asylum process is complicated and extremely difficult. Advocacy is growing to pass an Afghan Adjustment Act to obtain permanent residence status. To take action or express support visit:

- Legal service funding: House committee requested pilot project for 50 million for legal representation for people in removal. Would need at least 200 million to properly serve vulnerable populations seeking representation.
