Purpose: To receive comments on the City's Proposed amendment #2 to the 2009 Consolidated Plan and #4 to the 2008 Consolidated Plan for CDBG, HOME, ADDI, ESG, and HOPWA federal entitlement funding.

Dear Interested Individual/Agency:

You are invited to comment on Minneapolis' proposed Amendment #2 to the FY 2009 Consolidated Plan and Amendment #4 to the 2008 Consolidated Plan. The Consolidated Plan covers the City's Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), American Dream Downpayment Initiative (ADDI), Emergency Shelter Grant Program (ESG), and the Housing Opportunities for Persons with AIDS (HOPWA) federal entitlement funding and the 2005-09 Consolidated Plan Five Year Strategy.

Summary: Proposed Amendment #2 to the 2009 Consolidated Plan and Amendment #4 to the 2008 Consolidated Plan: The City through the direction of its Department of Health and Family Support proposes to cancel the CDBG-funded component of the Youth Are Here Buses from the 2008 and 2009 Consolidated Plans, the two years it was included for funding through the Consolidated Plan. The national objective for CDBG is serving low income populations. The Youth Are Here Buses program serves this population however federal CDBG program regulation compliance could not be achieved primarily based on two conditions: 1) the program's method used to determine eligibility of program participants was not in compliance with CDBG regulations, and 2) the program provides services selectively to youth only, which excludes others within the low income target area population. The City will continue to support the Youth Are Here Buses program and it will be funded through other funding sources. The CDBG funding originally directed to this program in 2008 and 2009 will be shifted to existing community-based public service programming previously approved through the Consolidated Plan (CDBG) and managed through the Department of Health and Family Support.

The City of Minneapolis is proposing to cancel the Community Development Block Grant (CDBG) funding for a Public Service program activity "Youth are Here Buses" described here and in the City's 2008 and 2009 annual Consolidated Plan budgets. Also, it is proposed this CDBG funding be transferred to other existing Public Service programming previously approved through the 2008 and the 2009 Consolidated Plans.

CDBG funds were budgeted but not expended for Youth Are Here Buses in 2008 and 2009. The CDBG funding originally directed to this program in 2008 and 2009 will be shifted to among other community-based Public Service programming previously described and approved the Consolidated Plan, funded through CDBG, and managed through its Department of Health and Family Support.
