1	Dismissed,	5-105(10) – Professional Code of Conduct [POLICY CHANGED POST]
	Cleared by Exception	Complainant alleges Officer 1 was directing traffic and had told her to stop. Complainant alleges she stopped her SUV but because of the size it did not stop right away. Complainant alleges Officer 1 came up to her window, hit it with his wand, and left a mark. Complainant alleges she spoke with Officer 1 who told her "b*llsh*t" that she was trying to stop, was rude, and told her he "was hoping to smash [her] window to get her attention."
2	Dismissed, No	5-104.01 – Professional Policing
	Basis	Complainant reported Officer 1 was directing traffic, approached his vehicle, and in a very harsh tone, asked why he did not stop sooner and nearly hit him. Complainant alleges it was clear from Officer 1's tone he wanted to get complainant to argue with him. Officer 1 cited complainant for reckless driving. Complainant alleges Officer 1 acted inappropriately, was argumentative, raised his voice, and was just plain belligerent and harassing.
3	Dismissed, No	9-200(c)(III)(1) – Search and Seizure
	Basis	Complainant alleges two officers arrived at her apartment during the middle of the night. Complainant alleges officers asked to see her ID, and when she politely tried to shut the door to go retrieve her ID, an officer stuck is foot in the door to prevent it from shutting. Complainant alleges officers stormed into her apartment uninvited.
4	Dismissed, No	5-104.01 – Professional Policing
	Basis	Complainant alleged the officer was rude and aggressive; tried to belittle her and threatened her several times. Complainant went to the precinct to file a complaint and alleges the officer would not take it. Complainant alleges she was harassed and racially profiled.
5	Sent to Coaching	7-401 – Normal Vehicle Operation
	– No Policy Violation or Coaching	Complainant alleges that while assisting a group of children in crossing a street when a walk sign was displayed, the group was approached by a police car with lights flashing. Complainant alleges the police car was visibly speeding and showed no sign of slowing or stopping for the children crossing the street.
6	Dismissed, No	5-303 – Authorized Use of Force
	Basis	Complainant reported a police officer pulled her over because her signal was not working. Complainant alleges officers snatched her phone out of her hand, threw her up against her truck and used excessive force upon her, causing injury to the back of her head, her right shoulder, and her lower back. Complainant also alleges she was taken to jail with 2nd degree burns on her left inner thigh, a fractured shoulder and back, and was having trouble breathing. Complainant alleges her injuries were not attended to and officers would not give her information about her arrest.

		officer's badge number to which they responded "It's on the citation, you f*ck*ng
		retard". Complainant alleges he was told to "Have a nice day, you *sshole" as he left
		the incident.
