SWS Planning and Design Intern

There are planning and design intern positions currently available to assist engineers working on the City's flood mitigation, CSO, and I/I Reduction Programs.

Location: City of Lakes Building, 309 South Second Avenue (Minneapolis). May occasionally include field work.

Job Duties:

- Create and organize hydrologic / hydraulic models used for flood analysis.
- Research and organize sanitary sewer and drainage system records.
- Complete field-investigations of sewer and drainage system infrastructure.
- Assist engineers with other tasks as assigned.

Minimum Qualifications:

- Working toward a Degree in Civil Engineering or related field.
- Exceptional computer skills, including expertise using Microsoft Excel.
- Ability to work independently.

Preferred Qualifications:

- Experience using ESRI ArcGIS, working with databases, and creating GIS data.
- Experience using XP-SWMM or other hydrologic / hydraulic modeling software.
