		Next, Complainant contends that he requested the officer to contact his sergeant to tak
		to him about the situation. Upon asking the officer to contact the sergeant,
		Complainant claims that the officer told him "No!" and kept asking for Complainant's
		driver's license. After giving the officer his license, Complainant asserts that he
		pushed the "OnStar" button in his vehicle and contacted the precinct, requesting a

4	Sent to investigation, dismissed - pending further information	5-313 Use Of Chemical Agents – Policy Complainant alleges that she was waiting with friends for an "Uber ride" when "[f]our officers on horsesthrew two devices that emitted smoke," leading her eyes to immediately swell shut. Complainant also contends that her friend began to throw up as a result of the smoke. Additionally, Complainant contends that she did not have any interaction with the officers prior to the incident and that she and others around her were law abiding. Lastly, Complainant asserts that her eyes were still swollen more than 16 hours after the incident.
5	Sent to investigation, dismissed - failure to cooperate	5-301.01 – Use of Force Complainant contends that she noticed a car speeding toward her at excessive speeds and moved so as to get out of the way of the approaching car by turning at a stop-sign and pulling over. After pulling over, Complainant contends that the car then turned on its lights as it approached the stop sign adjacent to where she pulled over. Upon parking, Complainant contends that Officer 1 approached her door and asked for her license, upon which Complainant asked why she was pulled over while her license was in her hand. Complainant claims that Officer 1 began to count to ten, and Complainant contends that she gave her license when he counted to 1.
		After giving Officer 1 her license, Complainant claims that he began to walk away and she began to dial 911. Following this, Complainant asserts that Officer returned to her car and asked that Complainant give him her vehicle registration. After opening her glove compartment to retrieve the registrationa 21-day temporary permit, Complainant contends that she asked the officer why she had been pulled over, to which he replied "suspicious vehicle". After handing the permit to Officer 1, Complainant asserts that Officer 1 walked away from the vehicle to speak to Officer 2. After speaking to Officer 2, Complainant asserts that Officer 1 asked for what was in her glove department, to which she told him "it was none of his business". After this, Complainant contends that Officer 1 began screaming at Complainant for having a "21 Day card". She also contends that it was at this point that the officer told her that she had to get out of her car or he would pull her out. Complainant alleges that she exited the vehicle and sat on a curb as instructed to by Officer 1.
		After sitting down on the curb, Complainant asserts that Officer 1 asked for the keys to her vehicle, to which she replied that she was calling 911 to speak to their supervisor. Complainant claims that "[f]rom that moment one officer grab[bed] my right arm" and the other officer her left arm. Complainant contends that she was pulled so hard that she hit the ground, after which an officer lifted her from the pavement and hit her head against the pavement three to four times. Complainant asserts that these actions led to a torn rotator cuff and also for her to plead for help. As she was pleading for help, Complainant claims that officers repeatedly punched her in the head. She also claims that one officer grabbed her thigh and attempted to

		reach into her pocket, especially troubling for Complainant as she contends to be a "victim of sexual abuse". She also asserts that one of the officers bent her wrist forward to the point that her hand touched her forearm, leading to a hand deformity. Further, Complainant claims that she screamed to the officer to "not break her wrist". After retrieving her keys, Complainant contends that one of the officers looked through her car while the other picked her up and slammed her against the squad window, leading to a broken jaw. She also contends that the officer began to choke her and only let go when she could no longer speak. Complainant asserts that the officers arrested her for Obstruct Legal Process and for illegal parking. Complainant admits to having a small bag of marijuana in the far left corner of her glove box. Nonetheless, Complainant believes that the officers did not have legal justification to even pull her over; in addition, she claims that they falsely reported that she was illegally parked. Complainant contends that she was never charged with marijuana possession and that the informant who called accusing her of prostitution lacked merit. Lastly, Complainant asserts that her raceblackand that of the officerswhite
		impacted their treatment of her.
6	Dismissed – no basis	5-105 (E)(2) – Professional Code of Conduct Complainant states that he was robbed by a "good buddy" and called the police thereafter. Complainant contends that, when trying to get information in relation to the incident, Officers 1 and 2 were rude to him. For instance, Complainant asserts that Officer 2 asked Complainant if he had "done anything" to the alleged perpetrator, which upset Complainant. When officers responded, Complainant contends that the officers failed to enforce her no trespass signs against the neighbor.
