1	Investigated, Panel recommended no merit, Chief agreed	<b>5-301- Use Of Force</b> Complainant alleges he was walking out of the restroom in the downtown Target when he was grabbed from behind by Officer 1. Complainant alleges that Officer 1 struck him in the head with his handcuffs when Complainant turned to see who grabbed him.
2	Sent to investigation – Dismissed, failure to cooperate	<b>7-1001.02 Spoken Language Interpreter Services</b> Complainant's boyfriend was involved in an incident with police. Complainant states she called and tried to make a police report about the incident. Complainant states she was transferred to the precinct and spoke with a male officer. According to Complainant, the officer questioned her about the incident. Complainant states she requested an officer be sent to her. Complainant states the officer said that could not be done, because nothing happened. The officer took Complainant's contact information and stated the sergeant would call her back, but Complainant states she never was. Complainant states she then took her boyfriend to the hospital. Complainant states while at the hospital she spoke with two officers about getting a translator. Complainant states that the officers she conversed with at the hospital had a bad attitude.
3	Sent to investigation, Panel found merit, Chief agreed, Officer suspended	<b>5-102 Code of Ethics</b> It is alleged that Officer 1 was stopped by a police department outside of Minneapolis. He was stopped while driving a vehicle registered to a work assignment. Officer 1 was issued a citation for speeding. Officer 2 of the outside police department alleged that Officer 1 was issued a citation for speeding. Officer 2 of the alleged that Officer 1 was rude and made derogatory and threatening comments to him after he issued him the citation. It is alleged that Officer 1 was driving the vehicle in violation of the agreement he signed with the work assignment in regards to the appropriate usage of said vehicle.
4	Sent to coaching, Officer coached, No policy violation.	<b>9-200(Iii)(B)(2)(B) Search And Seizure Of Vehicles</b> Complainant was stopped in his vehicle. Complainant alleges that his center console was broken during the stop.
5	Investigated, sent to coaching, No coaching or policy violation	<b>5-105(14) Professional Code Of Conduct</b> Complainant alleges he went to a precinct to report "sexual harassment" at a store downtown. Complainant alleges that when the female with him explained the situation, Officer 1 "insulted her [] accent." Complainant alleges that when he attempted to explain the issue, he was cut off by Officer 1 and insulted. Complainant alleges that Officer 1 told her that it was "not her problem" and asked Complainant to leave. Complainant alleges that when asked, Officer 1 would not provide her badge number but eventually "muttered it very quickly then insulted me when I asked her to repeat again."
6	Sent to coaching, Officer coached, No policy violation	<b>5-105(14) Professional Code Of Conduct</b> Complainant states officers pulled him over for passing on the right. The Complainant alleges the Officer 1 acted rudely and unprofessionally towards him, and that when he explained why he passed on the right to the Officer 2 he threatened to tear up his ticket and issue a reckless driving citation.
