Outcome		Description
1	Sent to coaching, Officer coached, no policy violation	7-406.02 Secondary Squads Pursuit policy review.
2	Dismissed, no Basis	5-105(E)(2) Professional Code of Conduct Complainant alleges that she was assaulted and threatened by another who was "harboring her daughter" but officers failed to take a report.
3	Dismissed, no basis	5-303 Authorized Use of Force It is alleged that Complainant was "tazed while sitting on [his] front steps" upon being asked for his identity and then thrown down on "the cement/grass." After his arrest, he claims he was taken to a hospital. He also alleges that "none of the officers had their bodycams on"
4	Sent to coaching, focus officer unidentifiable	7-401 Professional Code of Conduct Complainant alleges that an officer turned on a street prior to the allotted time for turns.
5	Dismissed, no basis	7-401 Normal Vehicle Operation It is alleged that an officer crashed his unmarked squad vehicle into a tree while on his way to work.
6	Dismissed, no basis	5-105(E)(2) Professional Code of Conduct Complainant alleges that she told officers that a neighbor had been choked and shoved by a neighbor. According to Complainant, one of the officers told her that nothing could be done as her alleged assailant was not in a domestic relationship with her and the officers did not witness it. Further, Complainant claims that the officers interviewed her alleged assailant for 20-25 minutes. Also, Complainant contends that the officers erroneously informed her that she could not get a harassment restraining order as the incident was not a domestic; however, Complainant asserts that she was able to get a harassment restraining order against the alleged assailant.
7	Dismissed, failure to cooperate	Criminal Conduct - No Policy Listed Complainant states the following: "I know this officer was smoking pot possibly doing coke on his anniversary also I know he prostitutes his wife for money to his partner and other cops and sleeps with some of their wives. He is on porn sites and has put my pictures up and I want proof they are down. Also his wife threatens to beat me up all the time and has been violent with me. He is talking about me and uses his data base to look me up at work even though I have told them everything in my past I am afraid of this cop for he believes he is above the law and is trying to character assassinate me because of everything I know about him and his wife."
8	Sent to coaching, no coaching or policy violation	5-303 Authorized Use of Force Complainant alleges that officers told them to "get the f*** out of the store" and used "violent body language" before apprehending them. Complainant also alleges that their folding knife was put on hold illegally, as it was not a part of the investigation.

9	Dismissed, no basis	<p>5-104.01 Professional Policing</p> <p>Complainant alleges that after parking her car, the owner of another vehicle accused her of hitting her car. Complainant contends that she told the owner that she hadn't and went to inspect the supposed damage only to find none. According to Complainant, the temperature was below zero, so she decided to enter her home. Complainant asserts that the owner of the vehicle and her partner began to pound on her front door and scream for 45 minutes until officers arrived. When officers arrived, Complainant claims that the officers told her it is illegal to leave the scene of an accident before exchanging information. Complainant contends that she retorted that no accident had occurred. After showing officers her insurance, Complainant claims that she was placed under arrest for leaving the scene of an accident. Complainant asserts that she was cited and eventually uncuffed.</p>
10	Dismissed, no basis	<p>9-200 Search and Seizure</p> <p>Complainant alleges that officers arbitrarily and capriciously "raid[ed]" her property in the middle of the night. Further, she claims that she called the precinct to find out why her property had been raided and was given three different explanations by officers, including that the property was raided by accident.</p>
