## Public Case Synopses

September 2015

Outcome		Description
1	Dismissed - No Basis	<b>7-707 PROCEDURES FOR PROCESSING VEHICLES HELD FOR EVIDENTIARY PURPOSES</b> Complainant alleges that her vehicle was towed without cause.
2	Sent to Investigation, Dismissed - no basis	<b>5-101.01 TRUTHFULNESS</b> Complainant was arrested by Officer 1 for bias motivated assault and an outstanding warrant. Complainant alleges that Officer 1 submitted a false CAPRS supplement with "malicious" accusations. Complainant alleges that Officer 1 coerced witness statements. Complainant alleges that Officer 1 omitted witness statements that "cleared" Complainant.
3	Sent to coaching, Officers coached, no policy violation	<b>7-501.01 TRAFFIC ACCIDENT REPORTS</b> Complainant states he and a friend witnessed a vehicle hit a bicyclist, and his friend called 911. Complainant states that when he tried to give the officer a statement on-scene, the officer would not take it. The Complainant states the officer took the statement of two women but looked at Complainant funny and refused to take his statement.
4	Sent to investigation, withdrawn	<b>5-105(2) PROFESSIONAL CODE OF CONDUCT</b> Complainant alleges he was rear-ended and then assaulted by the driver who hit him. The Complainant alleges officers were able to find the address of the vehicle owner but are not investigating the assault.
5	Sent to coaching, no coaching or policy violation	<b>5-105(14) PROFESSIONAL CODE OF CONDUCT</b> Complainant states one of his patients became agitated and assaulted a postal worker. Complainant alleges the police were called, and officers arrived. Complainant alleges the officer was unprofessional and disrespectful. Complainant alleges the officer questioned how the facility handled its patients and questioned why the postal worker did not remain on the scene. Complainant alleges this occurred in front of the resident.
6	Dismissed – no basis	<b>5-301- USE OF FORCE</b> Complainant alleges officers entered her apartment without papers or a search warrant to remove her son. Complainant alleges she asked officers to leave, and officers wouldn't. Complainant alleges officers grabbed her son, and as she was following them out an officer pushed her back under her throat.
7	Sent to investigation, Dismissed – no basis	<b>5-301- USE OF FORCE</b> Complainant alleges he ran from an incident location after he heard a woman screaming. Complainant was chased by officers. Complainant alleges he "laid down, when they told me to in a flat position, also known as airplane style." Complainant alleges that one officer "hopped" on his back and started punching him in the face. Complainant alleges that the same officer pushed his face against the driveway causing scrapes to his cheek and eyelid. Complainant alleges that another officer pulled his hair, causing one of his dreadlocks to be removed. Complainant alleges that the officer who transported him downtown stated, "you know a ass-whooping comes with running from us" while laughing.
8	Sent to coaching – no coaching or policy violation	<b>5-105(2) PROFESSIONAL CODE OF CONDUCT</b> Complainant alleges Officer 1 refuses to investigate her identity fraud.
9	Sent to investigation	<b>5-104 IMPARTIAL POLICING</b> Complainant alleges his employee was harassed by an off-duty officer when the employee was canvassing at the officer's home. It is alleged that the officer then followed the employee around, until the employee requested the off-duty officer call the police.
