- b. <u>RECAC Overview</u>
 - Members are to read and review Bylaws, Resolution, and past Meeting Minutes.
 - Notes on RECAC work to date
 - Original timeline was to get the SREAP established by February of 2019 there was not a lot of time for meaningful community engagement.
 - Part of the RECAC task is to develop an evaluation report, commenting on how the City went about structuring and supporting the group. Members will talk about our process, the challenge throughout the year and this first term, reflections on how sessions and meetings went.
 - RECAC is tasked with advising the City Council on their budget specific to racial equity. Last year the budget proposal was something like 800 pages and members were not able to give a robust analysis. RECAC sent a letter declining to give the full analysis. Joy had requested budget allocation for another full FTE, which RECAC was able to be assist with.
 - RECAC is seen as a community engagement component of the SREAP, so whatever we can do to share within and across our networks in our ward is part of the work.

- RECAC is working to get subcommittees established so that more work can be done between meetings.
 - One of the subcommittees is Engagement. We will go out and table events or have presence at things that are already happening, also bringing information from community back to the RECAC.
- The "real" work we have achieved came out of the subcommittee groups, so that is why we want to get those going again
 - Via subcommittee work, a letter was sent to the City Council, Mayor's Office and Metropolitan Council related to constituents being or witnessing metro transit officers harassing people on the light rail. We have questions about their training, a fact-finding mission in our advisory role so that we could bring information back to our Wards
