Community Specialist – People with Disabilities

- New role for the City
- Emphasizes community engagement, not just ADA compliance
- Supports residents with complaints about accessibility
- Supports City's Advisory Committee on People with Disabilities
- Supports City staff in improving digital and physical accessibility



About the surveys

- Two surveys developed:
 - Internal survey for Minneapolis City Staff in all departments
 - External community survey

Community survey translated into Oromo, Somali,
Spanish, and Hmong



About the community survey

- The survey was designed to:
 - Understand people's experience using city services
 - Understand familiarity with current accessibility services
 - Identify how the city can improve going forward
- 321 total survey responses
- 157 identify as having a disability

| Answer Choices | Responses | Total |
|-----------------------|-----------|-------|
| Live | 78% | 121 |
| Work | 42% | 65 |
| Visit | 40% | 62 |



How would you rate your ability to do the following?

| Choices | Challenging | Okay | Good | Total |
|--|-------------|------|------|-------|
| Get to where I need to go for work, shopping, and medical care | 25% | 45% | 30% | 103 |
| Get to where I need to go for leisure | 29% | 43% | 28% | 103 |
| Use City streets and paths | 37% | 40% | 23% | 102 |
| Take part in City activities | 50% | 31% | 20% | 101 |

How would you rate the accessibility of city programs, services, and activities for people with disabilities?

| Choices | Responses | Total |
|---------------------|-----------|-------|
| Accessible | 15% | 15 |
| Somewhat accessible | 74% | 72 |
| Not accessible | 10% | 10 |

How would you rate the accessibility of city facilities for people with disabilities?

| Choices | Responses | Total |
|---------------------|-----------|-------|
| Accessible | 18% | 17 |
| Somewhat accessible | 73% | 69 |
| Not accessible | 9% | 9 |

Overall, what grade would you give the city regarding accessibility within its programs and services? A is the highest and F is the lowest.

| A (highest) | 3% | 3 |
