October is National Disabilities Employment Awareness Month

The DREAM Act becomes a reality

For the first time ever in Minnesota, undocumented students who attended high school for at least three years and graduated from a Minnesota high school are eligible to receive in state tuition and student state financial aid in any public college or university. The measure passed by legislators and signed by Gov. Mark Dayton in May took effect this school year.



The new law was part of the legislative agenda supported by the City of Minneapolis and it will benefit hundreds of residents and their families in Minneapolis.

Neighborhood Stories: Marcy-Holmes and community organizing that worked



Not every successful neighborhood effort requires thousands of dollars. Marcy-Holmes Neighborhood Association (MHNA) recently used good solid, community organizing to defeat the proposed installation of freeway sound walls.

MnDOT had proposed a series of 20-foot sound walls as part of an I-35W expansion. While the proposal included a neighborhood input process, the process limited voting by the number of residents who could vote and weighted certain votes over others. Unreturned mail-in ballots – even those from vacant properties - were counted as "yes" votes supporting the sound walls.

MHNA opposed both the input process and the sound walls, claiming the new walls would further divide the neighborhood sliced by I-35W, would cost millions, and wouldn't significantly reducing noise. MHNA also argued that the sound walls would hurt quality of life by tearing out greenery planted by neighborhood volunteers.


MHNA addressed the issue from a variety of fronts. Board members became "citizen experts" on freeway sound walls. MHNA worked with MnDOT, convincing them to include information on the neighborhood group's position in their mailings. "VOTE NO" yard signs went up, raising awareness of the issue even amongst people just driving through the neighborhood. Most important, MHNA reached out and gained the support of absentee property owners, whose votes were crucial to defeating the proposed sound walls. In the end, enough "no" votes were received to prevent the construction of the proposed walls in Marcy-Holmes.

MHNA shared news of the victory, adding "WE WON!" to the yard signs - but it didn't stop there. MHNA provided MnDOT with recommendations on how to improve the community input process. As MHNA Executive Director Melissa Bean stated, "We want other neighborhoods to benefit from our experience".

One Minneapolis One Read - It's time to join the conversation



October brings several special events to One Minneapolis One Read, a community read where everyone in Minneapolis is invited to read the same book and join the conversation. This year's book is *A Choice of Weapons* by Gordon Parks. Parks, a photographer for Life magazine, writer, composer, artist, and filmmaker, was 16 when he moved from Kansas to Saint Paul, Minnesota in 1928.

This compelling autobiography, first published in 1966, tells how Parks managed to escape the poverty and bigotry around him, and launch his distinguished career, by choosing the weapons given him by "a mother who placed love, dignity, and hard work over hatred."

Oct. 7 - Gallery reception and program. Meet Robin Hickman, great-niece of Gordon Parks; Wing Young Huie, author of the book's foreword and photographer; and Steve Floyd, photographer.

Oct. 8 - Screening of *Half Past Autumn: The Life and Works of Gordon Parks*. The film will be followed by a panel discussion including the film's director Craig Rice, Parks' niece Robin Hickman, tpt filmmaker Daniel Bergin and The Loft Literary Center Associate

Program Director Bao Phi.

Oct. 11 - Community photography workshop. Nationally acclaimed photographer Jamel Shabazz will conduct an interactive community photography workshop. RSVP required by Oct. 7.

Oct. 24 - Photography exhibit opening reception and panel discussion. Two exhibits will include photographic works by Gordon Parks on loan from the Gordon Parks Foundation and works by students participating in the One Minneapolis One Read photography residency at Juxtaposition Arts. The students will work with nationally acclaimed photographer Jamel Shabazz using inspiration from Gordon Parks. RSVP required.


A Minneapolis pet license is your pet's free ride home

Minneapolis Animal Care and Control (MACC) is making sure lost pets find their way home though a newly refreshed pet licensing campaign. A public service announcement is now available on the City of Minneapolis YouTube channel: http://www.youtube.com/user/cityofminneapolis. In addition, a billboard campaign has been launched and Animal Control staff have canvassed in neighborhoods educating residents that all dogs and cats in the city are required to be licensed.

Licensing your pet support Minneapolis Animal Care and Control's work to create safe and healthy communities for people and animals. Plus, there are many benefits to pet licensing including:

- It's a free ride home. If your licensed pet is found in Minneapolis, it will get a ride home instead of a ride to the Animal Shelter.
- Your pet is more likely to get back home. Licensed pets are three times more likely than unlicensed pets to go home again.
- It makes our community safer by ensuring pets are vaccinated against rabies. There is no known cure for rabies.
- It's the law for dogs, cats, ferrets and rabbits. Unlicensed pet citation: \$100.
- It helps other pets. Your pet's license helps Minneapolis Animal Care and Control:
 - o Shelter and feed lost dogs and cats and find them new homes
 - Educate the public about responsible pet ownership
 - o Reunite lost dogs and cats with their owners.

Volunteers needed for Minneapolis Emergency Response Team: Cultural Services Unit

The City of Minneapolis is seeking a select group of community residents to actively serve in a new Minneapolis Cultural Services Unit as registered Hennepin County Medical Reserve Corps volunteers to assist in emergencies. The goal is to have a team of 12 to 20 trained community members able to support community disaster recovery and outreach activities. Members will gain valuable experience in the field of public health and safety and will serve as cultural liaisons for their communities. Minneapolis residents with strong connections to their respective cultural communities are being sought.

Preference will be given to applicants who:

- are bilingual in English and another language or represent a cultural group that primarily speaks English.
- have an interest in health and safety initiatives.
- participate in a background check.
- are willing to be on-call in case of emergency.

City in need of election judges

Are you interested in serving as an election judge, or do you know someone who is? Election judges are essential to a successful Election Day. They are the officials that staff local polling places, administer election procedures, and ensure that the rights of voters are protected on Election Day. Serving as an election judge provides an opportunity to learn about the elections process and is a great service to our community.

Although hundreds of people are already signed up to be election judges, Minneapolis is still in need of several hundred more judges to staff up for Election Day. Election judges open and close the

equipment, and record and certify vote totals.

To be an election judge, you must be:

- Eligible to vote in Minnesota.
- Willing to attend a two-hour training class
- Able to work either a full day (6 a.m. 9 p.m.) or a part-time shift (6 a.m. 2 p.m. or 2 p.m. 9 p.m.) on Tuesday, Nov. 5.
