Complainant also alleges that a crime prevention specialist intervened and her house was raided and false accusations were made against her and others in her home.
3	Sent to Investigation — Dismissed, Failure to Cooperate	5-301 Use of Force Complainant alleges her family was stopped by officers as they were removing supplies from a job. Complainant alleges her minor son was hit on the head with a flashlight. Complainant alleges when she asked officers why that happened, she was told to "stay away." Complainant alleges once the property owners confirmed Complainant's story the officers refused to believe her story and did not explain to Complainant's oldest son why his brother was hit. Complainant alleges officers tried to knock the cell phone from her eldest son's hand. Complainant alleges that when her eldest son was arrested, a group of officers took him to the ground, and pushed his entire body and head into the ground.
4	Sent to Preliminary Investigation – Dismissed, No Basis	5-301 Use of Force Complainant alleges the officer spit on him three times, called him a f***er, and threw him in the squad car. Complainant alleges he was not put in a seatbelt in the squad car.
5	Sent to Preliminary Investigation – Dismissed, No Basis	5-301 Use of Force Complainant was transferred to a hospital during a mental health crisis and arrived with a fractured left orbit, and it was bleeding.
6	Sent to Coaching, no coaching or policy violation	5-105(14) Professional Code of Conduct Complainant alleges she has a No Contact Order against her children's father. Complainant alleges she saw officers approach her home with him. Complainant alleges she saw her door was open and her children's father was moving stuff out of the garage. Complainant alleges she asked officers if she could get her key back, and the officers were nonchalant. Complainant alleges officers spoke to her as if nothing was wrong. Complainant alleges the officers had an unprofessional attitude and inappropriate tone. Complainant alleges she asked what if she changed her locks and the male officer stated "I would have to kick down the garage door." Complainant alleges she never received her key back, and officers tailed her for several blocks.
7	Sent to Investigation – Dismissed, Failure to Cooperate	5-301 Use of Force Complainant states an officer escorted him out of a store. Complainant alleges the officer pushed and dragged him out of the store and called Complainant a "tough mother*ck*r."
