## Background

### **NCEC Comments on the Neighborhoods 2020 Roadmap:**

On behalf of the Commission, Chair Cichowicz requests the Commission approve the NCEC's comments on the Neighborhoods 2020 Roadmap. This response was developed by the commission through its Neighborhoods 2020 Committee and the Committee of the Whole. All Commissioners were invited to be present through the development of this document.

### **Neighborhoods 2020 Workgroups:**

On Monday, the NCR department presented an update to Neighborhoods 2020 to the Public Health, Environment, Civil Rights and Engagement (PECE) Committee of the City Council. Within that update, Director Rubedor requested the PECE Committee to approve the structure and selection process of the three workgroups.

The PECE Committee approved the following:

The Minneapolis City Council hereby approves establishing three Neighborhoods 2020 Work Groups as set forth below, and directs the Neighborhood and Community Relations Department to move forward with the application process:

1. **Program Guidelines, Funding and Implementation** - Sixteen members with City staff as subject matter experts (non-voting):
  - (2) City Council representatives will be appointed by Council President Bender;
  - (1) Mayoral representative will be appointed by Mayor Frey;
  - (2) Neighborhood and Community Engagement Commission representatives and (1) Neighborhood Revitalization Program Policy Board representatives will be selected by each body at their May 2018 board meetings; and
  - (3) Cultural Community representatives, (5) Neighborhood representatives, and (2) Equity and Undoing Racism representatives will apply through an open application process and will be chosen by a committee of the Chair of the Public Health, Environment, Civil Rights, and Engagement Committee, two NCEC members, and two NCR staff.
  
2. **Governance Advisory Structure for Neighborhood and Community Engagement** - Seventeen members with City staff as subject matter experts (non-voting):
  - (2) City Council representatives will be appointed by Council President Bender;
  - (1) Mayoral representative will be appointed by Mayor Frey;
  - (2) Neighborhood and Community Engagement Commission representatives and (2) Neighborhood Revitalization Program Policy Board representatives will be selected by each body at their May 2018 board meetings; and
  - (3) Cultural Community representatives, (5) Neighborhood representatives, and (2) Equity and Undoing Racism representatives will apply through an open application process and will be chosen by a committee of the Chair of the Public Health, Environment, Civil Rights, and Engagement Committee, two NCEC members, and two NCR staff.
  
3. **Citywide Community Engagement Policy** – Sixteen members with City staff as subject matter experts (non-voting):
  - (2) City Council representatives be appointed by Council President Bender;
  - (1) Mayoral representative will be appointed by Mayor Frey;
  - (2) Neighborhood and Community Engagement Commission representatives and (1) Neighborhood Revitalization Program Policy Board representatives will be selected by each body at their May 2018 board meetings; and
  - (3) Cultural Community representatives, (5) Neighborhood representatives, and (2) Equity and Undoing Racism representatives will apply through an open application process and will be chosen by a committee of the Chair of the Public Health, Environment, Civil Rights, and Engagement Committee, two NCEC members, and two NCR staff.

The NCEC must select 2 representatives for each workgroup.

**Workgroup Selection Panel:**

Additionally, the PECE committee also approved the way in which Cultural Community representatives, Neighborhood representatives and Equity and Undoing Racism representatives will be selected to the work groups. After an open application process, they will be selected by a committee of the Chair of the Public Health, Environment, Civil Rights, and Engagement Committee, two NCEC members, and two NCR staff.

The NCEC must select 2 members to serve on this selection panel.
