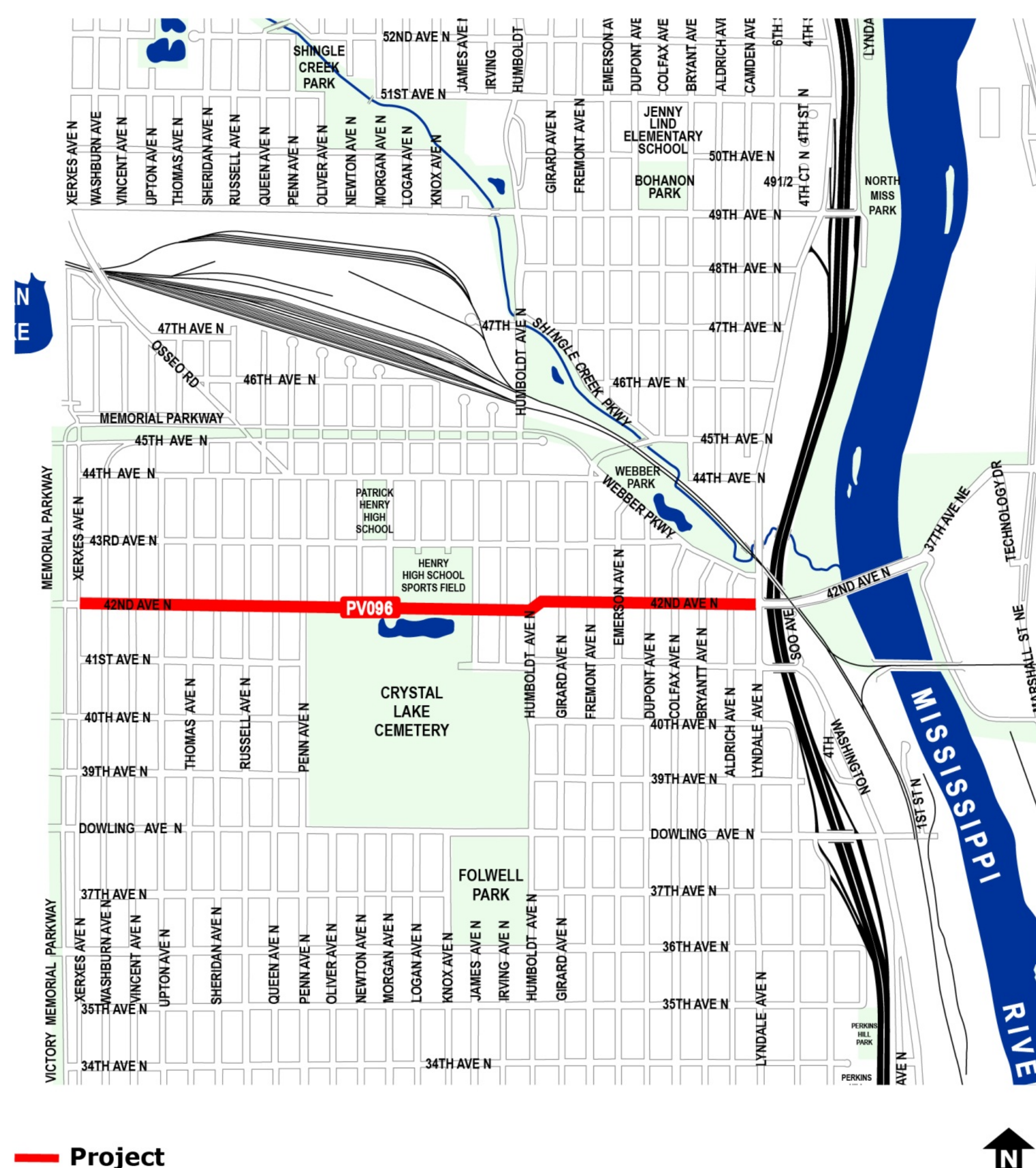
PROJECT PURPOSE

This project encompasses the entire right-of-way and will address deteriorating pavement conditions, gaps in the sidewalk network, non-ADA compliant pedestrian walkways, the on-street bicycle facility, and needed utility improvements.

PROJECT DELIVERY

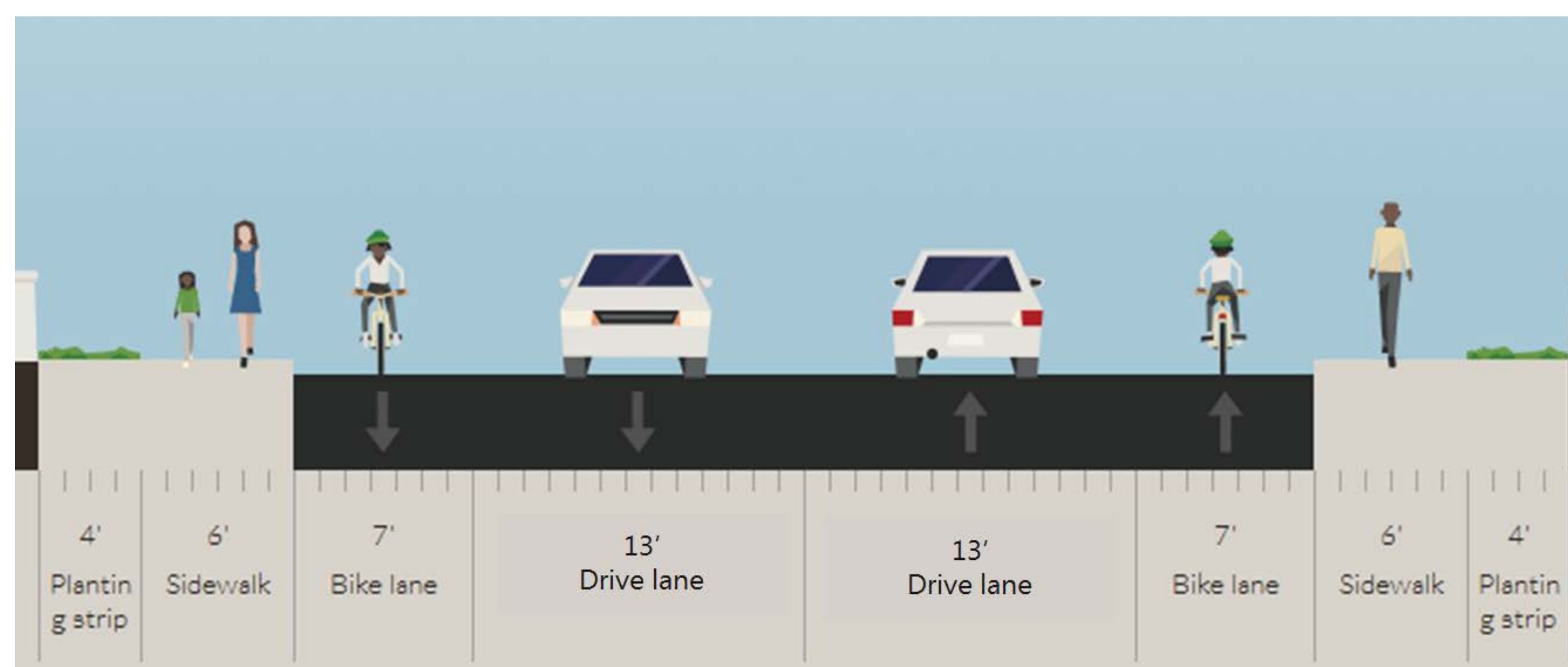
The proposed reconstruction of 42nd Avenue North is scheduled to occur over the course of the 2018 and 2019 construction seasons. Construction activities will consist of improvements to the roadway, sidewalk, and utilities. Other infrastructure that may be addressed as part of the project include improvements to the traffic signals, as well as new signage, curb/gutter, and pavements markings.

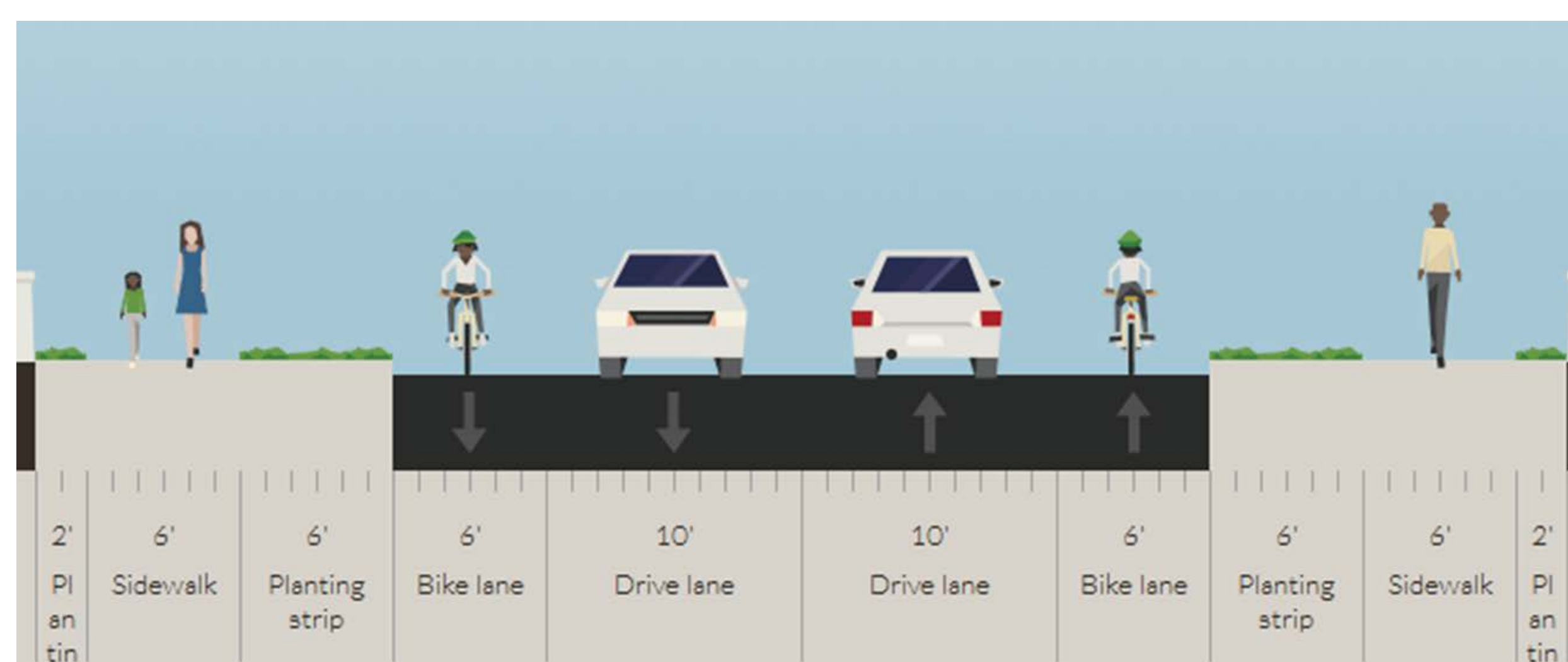


TYPICAL CROSS-SECTIONS
