Aging and People with Disabilities Community Briefing 5.20.20

 - Clearing 30 complete investigations a day
 - Does not count number of folks attempted to contact greater number
 - Taking and backfilling the state's efforts
 - Advocating for disaggregating data to the state to better respond and interact with folks

CPED

- Housing (Andrea Brennan)
 - housing assistance fund
 - over 8,000 applications
 - can serve 1500 households with the funding available
 - currently determining if applicants are eligible and found there are duplicates
 - final number after removing duplicates and verifiable Minneapolis address:
 6500 households
 - communicated with 6500 households via email and letter on where they are in the overall process
 - currently making referrals to MPHA for providing assistance directly with stable home stable school funding, along with 10 community partnering organizations
 - referrals are being made to community partners
 - applicants who selected a language preference are referred to organizations able to support in-language
 - 30% of applicants identified Latinx or preferred language is Spanish

- Hennepin county has approved \$15 million for residents in the county. Available to folks in early June
- Other resources listed on city's website: example, mortgage lenders providing forbearance
- Homeowner rehab program: continues to run through tis period of time, for homeowner with80% below media income for loans to improve homes and accessibility improvements

Business support (Erik Hansen)

- City's gap financing loans and opening businesses update
- City issued for loans of 5k/10k to business in targeted areas of need (ACP50, Minneapolis promise zone, green zone and cultural district)
- Received over 1200 loans
 - 800 were in the identified geographic areas
- Loans can be used for payroll, occupancy costs, etc...
- Able to support 140-200 businesses with the program
- City additional set 500k for other programs (ie 2% loans)
- Governor issued stay safe order
 - Non-critical businesses were selected to open
 - Retail, restaurants, etc
 - With restrictions and capacity to provide public health
 - Businesses can choose to open or not
 - June 1st is the target date for restaurants, health clubs, salons
 - City is working to establish guidelines based-on what the state is going to issue
 - Guidelines are built to support customers/clients, owners, and employees
- Are restaurants going to have outdoor seating space, to help with social distancing
 - Under mn guidelines
 - Businesses looking to open have to address a covid safety plan and public health concerns
 - City will provide guidance with the mindset of continue accessibility and movement
 - Will make sure there are accommodations
